LEED VERSION 2.2 FOR NEW CONSTRUCTION
AND MAJOR RENOVATIONS

I. MATERIALS AND RESOURCES

1. **M.R. Credit 4.1:** Recycled Content 10% (post – consumer plus 1/2 pre-consumer) **1 point**

Setzer's MDF Mouldings and Millwork are certified as Eco-Certified Composite Value Added Program (ECC-VA). Setzer Forest Products has completed and fulfilled the requirements Eco-Certified Composite ECC Sustainability Standard CPA 4-11. This Program certifies that the board used by Setzer Forest Products uses 100% recycled or recovered wood fiber, which surpasses the LEED 4.1 requirement for recycled content.

2. **M.R. Credit 4.2:** Recycled Content 20% (post consumer and 1/2 pre-consumer) **1 Point in addition to M.R. Credit 4.1.**

Setzer's MDF Mouldings and Millwork are certified as Eco-Certified Composite Value Added Program (ECC-VA). Setzer Forest Products has completed and fulfilled the requirements Eco-Certified Composite ECC Sustainability Standard CPA 4-11. This Program certifies that the board that we use, uses 100% recycled or recovered wood fiber which surpasses the LEED M.R. 4.2 requirements for recycled content.

3. **M.R. Credit 5.1:** Regional Materials 10% Extracted, Processed and Manufactured regionally: **1 point**.

Setzer's MDF Mouldings and Millwork are manufactured in Sacramento and Oroville California, and all cities within California are within 500 miles, (excluding the Imperial Valley), as well as Portland, Oregon; Boise, Idaho; Nevada, and Western Utah, and qualify for the LEED 5.1 requirements, for regionally manufactured product.

4. **M.R. Credit 5.2:**

Regional Materials 20% Extracted, Processed, and Manufactured Regionally: **1 point in addition to M.R. credit 5.1.**

Setzer's MDF Mouldings and Millwork are manufactured in Sacramento and Oroville California, and all cities within California are within 500 miles, (excluding the Imperial Valley), as well as Portland, Oregon, Boise, Idaho, Nevada and Western Utah and qualify for the LEED 5.2 requirements for regionally manufactured product.

II. INDOOR ENVIRONMENTAL QUALITY

1. **EQ Credit 4.2:** Low-Emitting Materials: Paints and Coating: - **1 point**

Setzer primes the mouldings and millwork with primer paints that have low VOC, substantially less than the Green Seal Standard GS-11 Paints limits of 50 g/L which should qualify for LEED EQ Credit – 4.2.

2. **EQ Credit 4.4:** Low- Emitting Materials: Composite Wood and Agrifiber Products **1 point**

Setzer's MDF Mouldings and Millwork all comply with California Air Resources Board Phase 2 requirements, and when required by the customer, we can provide MDF moulding and millwork which contains no added urea formaldehyde resins which would qualify for LEED EQ Credit 4.4.
